

CONDITIONS OF THE “3 MONTHS FREE” PROMOTION

Information document

Promoters: The organisers of the “3 months free” promotion (hereinafter, the **Promotion**) are: Meridiano S.A. Compañía Española de Seguros, with Tax ID A-18006296 and registered office at Av. Jean Claude Combaldieu, no. 5, 03008 Alicante, (hereinafter **Meridiano**) and BanSabadell Seguros Generales, S.A. de Seguros y Reaseguros, with Tax ID A-64194590 and registered office at c/ Isabel Colbrand, 22, 28050 Madrid (hereinafter **BSSG**) on a co-insurance basis, each of them participating 50% in the co-insurance, with Meridiano being the opening entity.

Promotional Period: From 20 March 2023 to 31 May 2023.




Participants: Those customers of Banco de Sabadell, S.A., natural persons of legal age and resident in Spain, who take out a Death Protection¹ insurance policy with a periodic premium during the promotional period and also take out or have taken out another Protection insurance policy, both through BanSabadell Mediación, Operador de Banca-Seguros Vinculado del Grupo Banco Sabadell, S.A.² (hereinafter, **BSM**), (hereinafter, the **Participants**), may take part in the **Promotion**.

Promotion: 3 free monthly payments of the total annual premium of the Death Protection insurance contracted.

Terms and Conditions of the Promotion:

- The Participant must i) take out a Death Protection insurance policy with a periodic premium during the promotional period, and ii) take out or have taken out another Protection insurance policy through BSM.
- The Policyholder must be the same in both insurance policies.
- The Policyholder must be up-to-date with the payment of premiums for both insurance contracts.
- All insurance policies must have been taken out through the BanSabadell Mediación broker²
- The Participant may choose the payment method that best suits their needs, with the following structure of bills:
 - **Monthly payment** method: they will enjoy 3 free monthly payments, and they will not pay the bills* for months 4, 5 and 6.
 - **Quarterly payment** method: they will receive 3 free monthly payments on their second quarter bill* in month 4.
 - **Half-yearly payment** method: they will enjoy 3 free monthly payments on the half-yearly bill* in month 1.
 - **Annual payment** method: they will enjoy 3 free monthly payments on the annual bill* in month 1.
