

**Life Care + Protection PROMOTION TERMS AND CONDITIONS**  
(from 03 May 2021 to 31 July 2021)

1. **Promoting Entity:** the promoting entity of this promotion is BanSabadell Vida, S.A. de Seguros y Reaseguros with Tax ID No. A-08371908 and its registered offices at C/ Isabel Colbrand 22, 28050 Madrid (hereinafter, the "Promoting Entity" or "BSV").
2. **Participants:** Banco de Sabadell, S.A. customers, natural persons, of legal age and resident in Spanish territory, who, through BanSabadell Mediación, Operador de Banca-Seguros Vinculado del Grupo Banco Sabadell, S.A. (hereinafter, "BanSabadell Mediación"), take out a Life Care, Life Care Mujer or Life Care Premium insurance policy (BSV<sup>1</sup> products) and who also take out or have already taken out a Home Protection insurance policy (BSSG<sup>2</sup> product), a Car Protection insurance policy (BSSG<sup>2</sup> product and Zurich<sup>3</sup>) and/or a Health Protection insurance policy (Sanitas<sup>4</sup>) during the Promotional Period (hereinafter, the "Participants") through the aforementioned broker may take part in this promotion. In the case of health insurance, the policyholder and/or the Insured party in the respective policy shall have the status of Participant.
3. **Promotional Period:** the Promotion will commence on 03 May 2021 and will end on 31 July 2021, inclusive (hereinafter, the "Promotional Period"), notwithstanding this, it may be extended, suspended or cancelled by the Promoting Entity at any time for just cause, informing the Participants accordingly.
4. **Terms and Conditions of the promotion:**
  - a. The Participant must have applied for and taken out a Life Care, Life Care Mujer or Life Care Premium insurance policy with an annual premium equal to or more than ONE HUNDRED AND FIFTY euros (€150) and taken out a Home Protection, Car Protection and/or Health Protection insurance policy within the Promotional Period prior to 31/12/2021.
  - b. The Participant, with Home Protection, Car Protection and/or Health Protection insurance in force during the campaign period, will receive the amount of the promotion when applying for and taking out a Life Care, Life Care Mujer or Life Care Premium insurance policy during the Promotional Period with an annual premium equal or more than ONE HUNDRED AND FIFTY euros (€150).
  - c. The policyholder must be the same in both insurance policies. In the case of health insurance, the policyholder and/or the Insured party in the respective policy shall have the status of Participant.
  - d. The Participant must be up to date on all premiums for their life, home, car and health insurance which form part of the promotion.
  - e. These Life Care, Life Care Mujer, Life Care Premium, Home Protection, Car Protection and/or Health Protection must remain in force for at least TWO (2) annuities.
  - f. If the Participant does not comply with the provisions of section e), BSV may claim the amount paid as a promotional incentive.
  - g. The Participant will only be entitled to one promotional incentive per Life Care, Life Care Mujer or Life Care Premium insurance taken out.
  - h. Excluded from the promotion are home, car and health policies that have been cancelled and subsequently reactivated or taken out again in the last TWELVE (12) calendar months.
  - i. Sabadell Blink Home Insurance and Sabadell Blink Car Insurance are excluded
  - j. All insurance policies must have been taken out through the BanSabadell Mediación broker.
5. **Promotional incentive:** consists of a one-off payment by BSV into the same bank account as the Life Care, Life Care Mujer or Life Care Premium life insurance payment, of:
  - a. **FIFTY euros (€50)** if the amount of the premium is equal to or greater than ONE HUNDRED AND FIFTY euros (€150)
  - b. Or **ONE HUNDRED euros (€100)** if the amount of the premium is equal to or greater than TWO HUNDRED AND FIFTY euros (€250)

The closing date to apply for the promotional incentive shall be 31/03/2022

6. **Delivery of the promotional incentive:** Participants who meet the promotional conditions will receive a communiqué from Banco de Sabadell, SA informing them of the link to the *website of the promoting entity*, which they must access to apply for the promotional incentive. The communication will be received:
  - In case 4a): within a maximum of 30 days after the date of payment for the last insurance contract taken out.
  - In case 4b): within a maximum of 30 days after the Life Care, Life Care Mujer or Life Care Premium insurance contract is paid.

On the aforementioned website, the promoter will ask Participants for the necessary data to prove their identity and status as Participants in the promotion, with the sole and exclusive purpose of proceeding to the payment of the promotional incentive. This data will be: given name, surname, National/Foreign Resident's ID no. and policy number of the Home Protection, Auto Protection and/or Health Protection in force and/or contracted during the

campaign period. Participants will be provided with full information on the processing of their personal data at the time this information is gathered.

Once the promotional incentive has been requested by the Participant via the link to the *website of the promoting entity*, BSV will pay the corresponding amount by bank transfer within FIFTEEN (15) days of the Participant's request.

The closing date to apply for the promotional incentive shall be 31/03/2022
